Document linking the Articles of Association and the Internal Regulations (the former Articles of Association of the de facto association)

3 PREAMBLE

- 4 The purpose of this document is to clarify the link between the Articles of Association of the non-
- 5 profit association 'Verband vun de Lëtzebuerger Guiden a Scouten' (the 'Association') and the
- 6 former text of the 1994 Articles of Association, amended in 2021, which now becomes the Internal
- 7 Regulations (the 'IR'). The Articles of Association meet the legal requirements for setting up a not-
- 8 for-profit association (ASBL), while the Internal Regulations cover the practical and organisational
- 9 aspects of Scouting's operations, in accordance with the tradition of the movement.
- 10 The coexistence of these two documents requires clarification to avoid any inconsistencies. This
- document establishes a methodology for resolving discrepancies between the Statutes and the
- 12 ROI and plans for a future revision of the ROI.
- 13 In the event of a discrepancy between the various documents, the following hierarchy is applied:
- 14 the law takes precedence over the Articles of Association, and the Articles of Association take
- precedence over the Internal Regulations (ROI). The provisions of the ROI shall be updated at
- 16 the time of the future revision to ensure their compliance with the Articles of Association and
- 17 Luxembourg law.

19 Structure and role of documents

- 20 1.1. The Association's Articles of Association describe the legal structure as an ASBL, in accordance with Luxembourg law. They cover:
 - The requirements relating to the governance of the Association (General Meeting, Board of Directors, etc.).
 - The responsibilities of members and the rules governing financial administration.
 - Procedures for appointing, excluding and managing members.
- 1.2. The ROI is derived from the de facto association's articles of association and governs the practical aspects relating to the scout movement. It includes:
 - The fundamental principles of scouting according to Baden-Powell, including the educational method.
 - The structuring of Scout groups, their day-to-day management and their educational objectives.
 - Local group membership procedures, local group commitments and the role of Scout leaders.
